7. Chocks Go Away request for donation

Appeal Letter from Paul Osbourne from Chocks Go Away requesting a donation towards consultants' costs incurred in objecting to the planning application 21/00626 (air strip at manor farm). It was pointed out a) as the PC had objected to this application originally and when it went out to consultation for a second time, b) when discussed at PC meetings all members of the public present had also objected and c) when canvassed a vast majority of the residents of Little Mongeham (the area of the parish most directly affected) were against the application it was decided to make a donation. Three hundred pounds donation was proposed by ClIr Akhurst and seconded by ClIr Willet and all councillors voted in favour other than ClIr Steger who did not take part in the vote due to her declared interest. Payment cheque to be issued and details to be reported to the October meeting.

8. CPRE The Countryside Charity membership renewal

It was proposed by Cllr Merriman that we go with the lowest quote (H.G Tree Surgery and £1000 for hedge cutting and £600 for gate post replacement) seconded by Cllr Densham and all members voted in favour.

iv)Future grass cutting contract. Contractors work has now improved to acceptable levels. The three year contract comes to an end in the spring. Clerk to find out when. Then to be decided whether any areas of long grass in the recreation ground to be left for wildlife in the growing period. To be added to October agenda.
