3. Approval of the minutes 3rd January 2023

4. Matters arising from the minutes 3rd January 2023

Cllr Akhurst and Cllr Willet have finished cutting back the branches at the Millennium bank, Jacks Bush and BMX track. Cllr Willet has kindly taken away all the branches.

6. Finance

i) To approve the payment schedule for January was proposed by Cllr Willet seconded by Cllr Caltrope and all members voted in favour.

8. Update on renewal of Grass Cutting Contract

At the moment only one quote has been received. Clerk to follow up with other potential individuals and show them the areas that need cutting. To go on March agenda.

9. Local Community

- i) Update on road salt bins. Some of the salt was delivered by KCC Highways. Clerk requested some more to be delivered to Cllr Densham, but had not received yet. One salt bin located at the Boys Hill and owned by the Parish Council had gone missing. Clerk to get a quote for a salt bin. Clerk to follow up with Highways about the salt delivery.
- Update on blocked drain outside the nursery. This was reported to Highways back in September and has not been completed. After several emails the clerk has received an apology and confirmation from KCC that the works will be completed within 28 days.
- iii) The Nursery building development and parking on the green verge. Cllr Merriman has emailed a report that vehicles have been parking on the verge and some lorries have been breaking up the bank. Cllr Merriman had spoken to one of the workers and passed on the message to the manager that they need to find other arrangements for the contractors cars.
- iv) Flooding at the bottom of Strakers Hill, opposite the community hall. Clerk to report this to KCC Highways.
- v) Update on potholes survey by Highways on Roman Road. KCC has completed this task.
- vi) Update on potholes survey by Highways on Homestead Lane. KCC works been programmed.
- vii) Update on Local Bus services. KCC still working with Stage Coach to see if there are any opportunities to replace this service.

12. Report from DDC/KCC

KCC member Steve Manion reported on the following:

The financial pressure on local authorities as they are setting the budget for 2023/24 The inflation at the moment is around 10 per cent and the council tax can only go up by 5 per cent. New household support scheme is available for house holds struggling with the energy bills. It's a one off support of one hundred pounds towards the energy bills. DDC member Nick Kenton reported on the following:

Financial pressure on DDC as they are trying to keep the community sport centres and swimming pools open.

A £45 million grant was confirmed for Dover Port to develop their infrastructure. Due to health and safety issues the green waste project has been delayed for a year.

- ii) The new measurements for two new plots update. Cllr Akhurst thanked Doug Vickers for measuring out the two new plots. Clerk to contact people on the waiting list.
